NEW / UPDATED CHARTER PAYMENT POLICY

The San Diego fleet has made a few trips for Rock fish and scattered yellowtail in Mexican waters. The log range fleet is concentrating on big yellow fin tuna at Hurricane Bank.


REGULATION CHANGE FOR SAND BASS

The California Fish and Game Commission will consider a proposal to restrict further or close altogether the taking of Sand Bass. The current regulation includes Calico Bass, Sand Bass and Spotted Bay Bass as a single unit. The daily bag limit is 5 fish total, minimum length 14 inches. The various options will break Sand Bass out of this with a possible no take limit during critical spawning season of June through August. Other options are no take altogether or some significantly reduced daily limit.

Sand Bass traditionally spawn at Huntington Flats and the Rincon in early to mid-August. It was normal to take a local boat out in August, spend a couple of hours at the Rincon and get near limit of Sand Bass. Then when the Humboldt Squid arrived, they destroyed the Sand Bass spawn at both Huntington Flats and the Rincon in 24 hours. The Sand Bass population has never recovered from that massacre.

The CCA has organized a protest against the proposed closure. Their argument is that catch counts do not accurately reflect the population and there is no scientific calculations on the status of the Sand Bass population overall. Both arguments are true, but to me are not convincing. First, catch counts cut both ways. Several years before the Calico Bass bag limit reduction and minimum size limit increase, I reviewed a scientific paper which stated the Calico Bass population was in steep decline, but the catch totals were stable because skippers were fishing areas which were previously ignored because of weather or current difficulties. And as predicted, the failure to take action at that time led to an almost total collapse and today's bag limit restrictions.

Second, the gathering of population data takes sampling over a significant period of time and the precipitous decline in catch totals over past few years indicates immediate action is far more prudent. At worst case, it will allow population recovery closer to historic levels prior to the Humboldt Squid attacks.

COOKING YOUR CATCH

White Sea Bass with Orange-Fennel Relish

Fresh on the palate. Slightly licorice flavors from the fennel combine with citrus of the orange juice to provide a wonderful springtime or summer dish.

INGREDIENTS:

- 2 tablespoons extra-virgin olive oil
- 1 tablespoon fresh lemon juice
- 1 tablespoon fresh orange juice
- 1/2 teaspoon grated orange rind
- 3/8 teaspoon kosher salt, divided
- 3% teaspoon freshly ground black pepper, divided
- 1 (12-ounce) fennel bulb
- 1 cup fresh orange sections
- 1/4 cup thinly sliced red onion
- 2 ounce halved castelvetrano olives (about 1/2 cup)
- 4 (6-ounce) white sea bass fillets
- 1 1/2 teaspoons butter
 - Combine first 4 ingredients, ¹/₈ teaspoon salt, and ¹/₈ teaspoon black pepper in a medium bowl, stirring with a whisk. Remove fronds from fennel bulb; chop fronds to measure 2 tablespoons. Remove and discard stalks. Cut fennel bulb in half lengthwise; discard core. Thinly slice fennel bulb. Add sliced fennel, orange sections, onion, and olives to orange juice mixture; toss gently to coat. Stir in fennel fronds.
 - Heat a large nonstick skillet over medium-high heat. Sprinkle fish evenly with remaining ¼ teaspoon salt and remaining ¼ teaspoon pepper. Add butter to pan; swirl until butter melts. Add fish to pan; cook 4 minutes on each side or until desired degree of doneness. Serve with relish.
